**Purpose:** This form allows the MA Board of Directors to follow a regimented process for the review and selection of volunteers to fill coaching positions for the upcoming MA season. Prior to any individual being selected for a position as a Head or Assistant Coach they must submit a completed application, agree to a background check, and be interviewed by the current Board of Directors. The information collected will only be used as the basis for review and ultimate recommendation to the MA President for final approval of appointment of the applicant to participate in a coaching position. We do not anticipate challenges; however, we are committed to maintaining a quality and safe environment for all participants. All results will remain confidential. Assistant coaches/instructors are selected by the Head Coach and approved by the VP of Football/VP of Cheer.

**Privacy Policy:** MA collects information from coaching applicants for the purposes of determining eligibility and suitability and to conduct background investigations necessary to insure the safety of our participants. We will not collect any information that is not reasonably necessary to participate in this program. Except for the information necessary to conduct background investigations, we will not disclose applicant information to any third party.

**Instructions:** Please fill out ALL the information requested. No person shall be considered for any position within the MA coaching staff until a completed application is submitted and approved by the MA President. Also, by volunteering you agree to follow all rules and regulations as set forth by MA Board of Directors and understand that failure to comply with all rules can result in termination as a volunteer coach.

1. I have not been convicted (including crimes the record of which has been expunged or pleas of “no contest”), disciplined, or discharged from employment for committing or attempting to commit crimes in but not limited to:
  - Child abuse
  - Sexual abuse of a minor
  - Physical abuse
  - Murder
  - Manslaughter
  - Felony assault
  - Kidnapping
  - Arson
  - Criminal sexual conduct
  - Neglect of a child
  - Abuse causing a child’s death
  - Prostitution related crimes
  - Child pornography
  - Child exploitation
  - Controlled substance crimes
  - Juvenile prostituting or pimping
2. I have not been convicted of any offense in any other state or against the laws of the United States which if committed or attempted in this state would have been punishable as one or more of the foregoing enumerated offenses.
3. I have not been adjudged liable for civil penalties or damages involving sexual or physical abuse of children.
4. I have not been subjected to any court order involving any sexual abuse or physical abuse of a minor, including but not limited to domestic order for protection.
5. I have not ever had my parental rights terminated.
6. I understand that I have an ongoing obligation as a volunteer of this organization to promptly report any conviction in those areas described above.
